Terms& Conditions

Form - "O"

In accordance with Rule 42-48 of the Municipal Corporations (Taxation) Rules 1986

- (A) Dhaka North City Corporation reserves the right to suspend, revoke or cancel the Trade License for any valid reason at any time.
- (B) This Trade License shall not create any right for land or rent related ownership. And shall not be used for claiming any position, tenancy or any kind of legal ownership.
- (C) This Trade license should not be used for any purpose other than the trade, calling or occupation it has been issued for.
- (D) After issuance of this license, if it is found that any wrong declaration was furnished in the application form, or terms and the conditions under which it was issued are violated the license shall be liable to cancelation
- (E) This license is not transferable, however in case of change of ownership or relocation of business in the same area, the licensee is required to submit an extra 10% of the original fee of the license along with the prior approval of the concern taxation officer.
- (F) No alteration, addition, or modification of the trade license canbe made without the approval of the appropriate authority.
- (G)The licenseeshould not operate any business which is regarded harmfulto public health, dangerous to public safety and which is or likely to be nuisance to public.
- (H) Licenseeshall not conduct any activity subversive to the State.
- (I) The licensee shall keep the license at the business location in a mannerso as to theauthorized officials of the city corporation can easily notice during any inspection.
- (J) If this license is lost or damaged, a general diary has to belodged to the nearest Police Station and the concern taxation officer has to be informed about theaforesaid incident.
- (K) The licensee should be legally bound to follow any additional instructions made by the Licensing Authority time to time.
- (L)This license can be renewed without any surcharge from 01 July to 30 September for any given year. The licensee shall attach a photocopy of the latest rent receipt during the renewal of the license.
- (M) The licensee has to submit the license to the authorized taxation officerimmediately after the closure the business for which the license was issued.
- (N) If any person or organization operates business in the jurisdiction of the Dhaka North City Corporation without appropriate trade license or without getting the license renewed, the City Corporation may take legal actions under section92 of the Local Government (City Corporation) Act 2009 as stated in Sections 1 and 3 of the Fifth Schedule of the said act.
- (O) This license will be revoked if any evidence is found regarding engagingminors in hazardous work.
- (P) The licensee must keep his/her business premise healthy and environment friendly by following proper waste disposal system.
- (Q) This license shall be deemed void for any breach of the above conditions.
